## What are the difficulties? What should customers be aware of?

Policies are often adjusted suddenly. Without real-time information, it is easy to have goods detained for non-compliance with new regulations.
2. **High Requirements for Document Compliance:** The Philippines’ requirements for clearance documents such as invoices and packing lists are nearly stringent. Any discrepancy in product name description, under-declared value, or coding error will be regarded as “false declaration,” triggering huge fines or even return shipment.
3. **Complex Taxes and Import Permits:** Certain specific goods (such as products containing batteries, medical devices, etc.) require specific import permits (such as IVP/DPS). Without a local team to assist in the application, goods cannot complete formal importation.
4. **Huge Risks of “Gray Clearance”:** Many small freight forwarders promise “inclusive clearance” at low prices by using illegal means. Once investigated, goods will not only be confiscated, but the shipper may also face the risk of being blacklisted.

**Background:** The customer needed to ship a batch of Bluetooth headphones (containing built-in lithium batteries) to Manila, Philippines, totaling 50 boxes, about 300kg. Since Bluetooth headphones are a common inspection target in the Philippines, the customer's previous logistics partner failed to provide qualified clearance documents and had poor

communication with the local agent, causing the goods to be held at customs for up to a week. The customer faced the risk of stockout at their store.
