

# How To Ensure Lithium Battery Air Shipping Compliance For Safe Delivery

## What category does lithium battery transportation belong to?

Before exploring air shipping for lithium batteries, we need to clarify a core concept: the transportation of lithium batteries is classified as [dangerous goods transport](#).

According to the "Dangerous Goods Regulations" (DGR) published by the International Air Transport Association (IATA), lithium batteries are classified as Class 9 dangerous goods (miscellaneous dangerous substances and articles). Although lithium batteries are extremely common in our daily lives, in the high-altitude environment of air transport, factors such as air pressure changes and vibration mean that improperly packaged or handled lithium batteries can easily overheat, short-circuit, or even catch fire and explode.

Therefore, air shipping of lithium batteries is by no means the transport of ordinary goods; it is subject to the strictest regulations by IATA (International Air Transport Association) and ICAO (International Civil Aviation Organization). Whether they are standalone batteries (PI965 Section IB/II), batteries packed with equipment (PI966), or batteries contained in equipment (PI967), they must comply with strict packaging instructions and labeling requirements.



## What should shippers pay attention to when operating

# lithium battery air shipping?

Due to the complexity of "lithium battery air shipping compliance", as a shipper, you must pay attention to the following compliance thresholds before shipping:

- **Complex Documentation Preparation:** You must provide authentic MSDS (Material Safety Data Sheet), UN38.3 test summary, and 1.2-meter drop test reports. The watt-hour rating of the batteries must be accurately marked.
- **Strict Packaging Requirements:** You must use UN-standard dangerous goods packaging boxes and ensure that battery electrodes are effectively isolated to prevent short circuits.
- **Standardized Labeling:** The outer packaging must display the correct Class 9 dangerous goods label, handling label (Cargo Aircraft Only), and UN number.
- **Rigorous Flight Screening:** Not all airlines accept lithium battery bookings, and space is extremely tight during peak seasons. Once goods are intercepted by security due to documentation issues, it will result in high fines and delays.
