Malaysia's Import Taxes

Malaysia imposes import taxes on various goods to protect domestic industries and manage trade balances. While specific tax rates can vary depending on the product category and origin, the general structure includes:

Product Category	Typical Import Tax Rate	
Electrical Machinery and Equipment	Varies, often around 5-10%	
Automotive Parts	Varies, often around 10-15%	
Textiles and Apparel	Varies, often around 5-8%	

These rates are subject to change based on trade agreements and domestic policies[^49^].
